How to Define Authorizations

Introduction

This document provides information about the authorization settings in the *Authorizations* window in SAP Business One. For more information about the authorization function, see the online help for SAP Business One.

In the *Authorizations* window, you can determine the required authorizations for the users in your company.


You can also grant authorizations for creating, updating, and deleting documents in the *Data Ownership Authorizations* window. Only a user defined as *Superuser* (*Administration* → *Setup* → *General* → *Users – Setup*) can access the *Authorizations* submenu and grant authorizations for other users.

A user defined as *Superuser* has full authorization to all SAP Business One modules and functions and it is not possible to modify the authorizations for this user.

Within a module, when different components have different authorizations, the module authorization is displayed as *Various Authorizations*. For example, in the *Sales* module, if you have *Full Authorization* for the sales quotation, but *No Authorization* for the sales order, *Sales* is displayed as *Various Authorizations*.



This document relates to a *Professional User* license. Other license types have a fixed set of authorizations.

Authorizations Window

The main pane of the *Authorizations* window contains a list of modules and functions. To expand its content, click  next to a module or a function name.

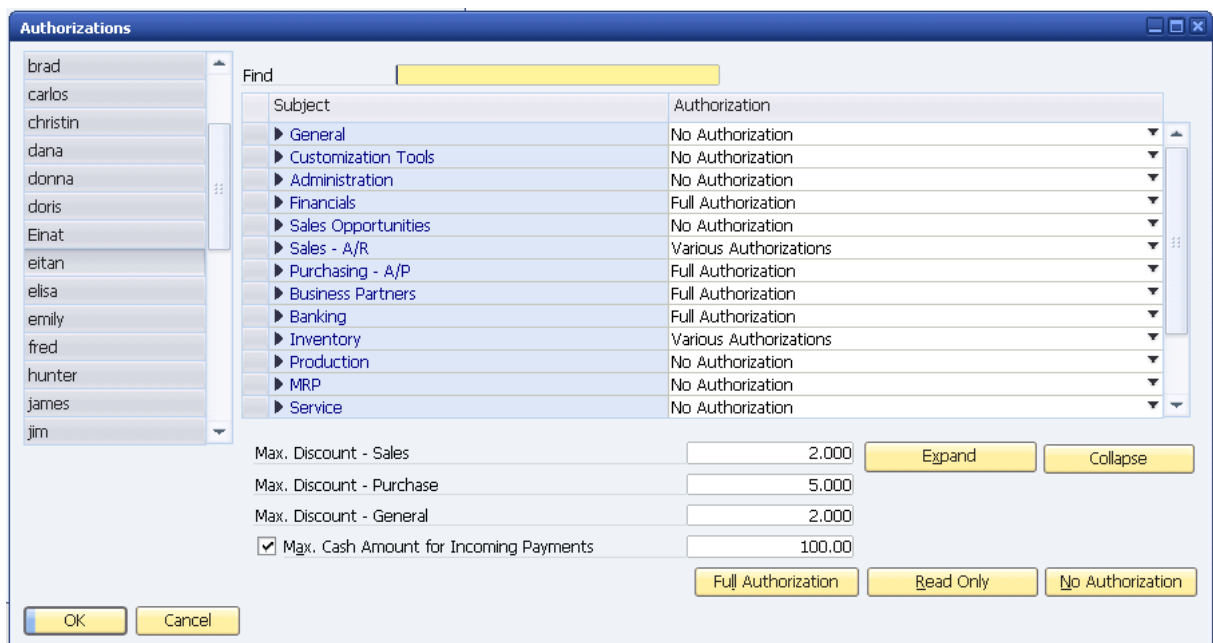
The column to the right of the function names displays the authorization type granted for the module, window, function, or action.

Note

In the *Authorizations* window, the functions appear in a hierarchical structure. The Expand icon () in a row indicates that the function contains additional functions at a lower level. The authorizations set at the higher level apply to all its lower level functions. To set each lower level function individually, click  to expand the hierarchy and set the authorizations for the specific function.

To open the *Authorizations* window, proceed as follows:

From the SAP Business One *Main Menu*, choose *Administration* → *System Initialization* → *Authorizations* → *General Authorizations*. The left side displays a list of all users defined in the company.



To define authorizations for a user, select a user from the list.

Copying Authorization Profiles from One User to Another

After defining the general authorizations for a certain user, you can copy his or her authorization profile to another user.

Prerequisite

- Ensure that the users are already defined in the company.

Procedure

To copy authorizations to multiple users:

1. In the *Authorizations* window, on the left side, select a user who has the authorizations that you want to copy.

Note

To check the authorizations for specific users, select a user and in the *Authorization* column, the permissions for the selected user are displayed.

2. Drag and drop the user name onto the name of the user to whom you want to copy the authorizations.
3. In the *System Message* window, choose the *Copy* button.
4. Choose the *Update* button, then choose the *OK* button.

The second user now has the same authorizations as the first.

The following behavior applies when changing authorizations in SAP Business One:



- When you change the authorization of a parent article, for example, from *No Authorization* to *Full Authorization*, the change is applied automatically to all the child authorizations below it.
- If you change the parent article to *Read Only*, and one or more of the child authorizations do not include the *Read Only* option, this child authorization is set with the value *No Authorization*.
- When you change an authorization that has a parent article, and that parent article represents an application window (for example, the authorization for the *Business Partner Master Data* window under *Business Partners* in the Authorizations tree), the parent article is not influenced and retains the same authorization it had before the child authorization was changed.
- When you change an authorization that has a parent article, and that parent article represents a menu entry in SAP Business One, but with no application window (for example, *Setup*, under *Administration* in the Authorizations tree) the following behavior applies:
 - If after the change of the child authorization, the values of the child authorizations below the specific parent article vary (for example, one child authorization is set to *No Authorization* and the other is set to *Full Authorization*), the parent article is set with the value *Various Authorizations*.
 - If after the change of the child authorization, all of the child authorizations of a specific parent article are set to the same value, the parent article is set to that value as well.


General Authorizations

The following modules and functions define the *General* authorizations:

<i>General</i>	<ul style="list-style-type: none"> • <i>Full Authorization</i> – You can enter all <i>General</i> functions and make required changes or new settings. • <i>Read Only</i> – You can view the data defined in all the <i>General</i> functions. • <i>No Authorization</i> – You cannot access any option specified in the <i>General</i> functions. <p>i Note</p> <p>If you select the <i>Read Only</i> authorization for the entire list of <i>General</i> functions, functions for which this authorization is not available are automatically set to <i>No Authorization</i>.</p>
<i>Send Message</i>	<ul style="list-style-type: none"> • <i>Full Authorization</i> – You can open the <i>Send Message</i> window (<i>File</i> → <i>Send</i> → <i>Send Message</i>) and send messages. • <i>Read Only</i> – You can open the <i>Send Message</i> window but cannot send messages. <p>i Note</p> <p>Authorization for document printing is required to send documents as e-mail attachments. The e-mail layout is defined in the document's printing properties.</p> <p>To save a distribution list when sending e-mails or SMS messages, you require authorization for the document settings (<i>Administration</i> → <i>System Initialization</i>). The <i>Read Only</i> authorization gives you the ability to view a saved distribution list. With full authorization, you can save a new distribution list.</p> <ul style="list-style-type: none"> • <i>No Authorization</i> – You cannot open the <i>Send Message</i> window.
<i>Print Layout Designer</i>	<ul style="list-style-type: none"> • <i>Full Authorization</i> – You can use the <i>Print Layout Designer</i> functions, such as modifying existing print templates and creating new print templates, for sales and purchasing documents. • <i>No Authorization</i> – You cannot use the <i>Print Layout Designer</i> functions.
<i>Change Default Report</i>	<ul style="list-style-type: none"> • <i>Full Authorization</i> – You can change the default print layout currently defined for a certain document or report.

Field Name	Description
	<ul style="list-style-type: none"> • <i>No Authorization</i> – You cannot change the default print layout currently defined for a certain document or report.
<p><i>Query Print Layout</i></p>	<ul style="list-style-type: none"> • <i>Full Authorization</i> – You can open the <i>Query Print Layout</i> window and modify the user-defined query print template. <p>i Note</p> <p>To open a template, you need authorization for <i>Print Layout Designer</i>.</p> <p>To open <i>Print Layout Designer</i>, you require <i>Read Only</i> or <i>Full Authorization</i> rights for the specific document or report.</p> <p>To print the query, you require authorization in the <i>Sales</i> module for document printing.</p> <p>To create a new query print layout, you require <i>Read Only</i> or <i>Full Authorization</i> or higher for the query generator and for <i>Saved Queries – Group No. 1, 2</i>, and so on.</p> <ul style="list-style-type: none"> • <i>No Authorization</i> – You cannot open the <i>Query Print Layout</i> window.
<p><i>Document Settings</i></p>	<ul style="list-style-type: none"> • <i>Full Authorization</i> – You can open the <i>Form Settings</i> window (<i>Tools</i> → <i>Form Settings</i>) and access the <i>Document</i> tab. <p>i Note</p> <p>To modify the settings in the <i>Table Format</i> and <i>Document</i> tabs, including changing and/or deleting fields at the row level in sales and purchasing documents, you require authorizations for the following fields:</p> <ul style="list-style-type: none"> ○ <i>Sales Employee Update</i> ○ <i>Price Lists</i> <p>To provide a discount, you must define the <i>Max. Discount</i> value in the <i>Authorizations</i> window.</p> <ul style="list-style-type: none"> • <i>No Authorization</i> – You can open the <i>Form Settings</i> window (<i>Tools</i> → <i>Form Settings</i>), but you cannot access the <i>Document</i> tab.
<p><i>Edit Document Tables</i></p>	<ul style="list-style-type: none"> • <i>Full Authorization</i> – You can open the <i>Form Settings</i> window (<i>Tools</i> → <i>Form Settings</i>), access the <i>Table Format</i> and the <i>Row Format</i> tabs, and make changes to the display of fields and columns. • <i>No Authorization</i> – You can open the <i>Form Settings</i> window (<i>Tools</i> → <i>Form Settings</i>), but you cannot access the <i>Table Format</i> and the <i>Row Format</i> tabs.
<p><i>Access to Confidential Accounts</i></p>	<ul style="list-style-type: none"> • <i>Full Authorization</i> – You can view G/L accounts marked as Confidential (<i>Financials</i> → <i>Chart of Accounts</i> → <i>Confidential</i> field); you also must have <i>Read Only</i> or <i>Full Authorization</i> rights

	<p>for the chart of accounts.</p> <ul style="list-style-type: none"> • <i>No Authorization</i> – You cannot view confidential G/L accounts in the chart of accounts or in any report that displays G/L accounts. In addition, confidential G/L accounts are not displayed in any <i>Choose From</i> lists displaying G/L accounts.
<i>Account Balances</i>	<ul style="list-style-type: none"> • <i>Full Authorization</i> – You can view the balances of G/L accounts in the chart of accounts and generate reports with account balance data; you also must have <i>Read Only</i> or <i>Full Authorization</i> rights for the chart of accounts. • <i>No Authorization</i> – You cannot view data about G/L accounts in financial reports, such as the <i>General Ledger</i> report.
<i>BP Balances</i>	<ul style="list-style-type: none"> ○ <i>Full Authorization</i> – You can view the balances of business partners displayed in the <i>Business Partner Master Data</i> window and in the <i>Account Balance</i> window. You also require <i>Read Only</i> or <i>Full Authorization</i> rights for business partner master data. To open the account balance from a sales document, you need full authorization for the sales order and delivery. ○ <i>No Authorization</i> – You cannot view data for business partners or in financial reports such as the <i>General Ledger</i> report. In addition, the <i>Account Balance</i> field in the <i>Business Partner Master Data</i> window displays asterisks (****) instead of the actual balance. <p>i Note</p> <p>If users have no authorization to see business partner balances, you must also prevent them from seeing all documents relating to the business partner. Beside the <i>Account Balances</i> field, click  (<i>Show Graph</i>) and ensure that the <i>Sales Analysis</i> and <i>Purchasing Analysis</i> fields in the <i>Authorizations</i> window (<i>Sales – A/R</i> and <i>Purchasing – A/P</i> → <i>Sales Reports/Purchasing Reports</i>) are set to <i>No Authorization</i>.</p>
<i>Unformatted Text</i>	<ul style="list-style-type: none"> • <i>Full Authorization</i> – You can export data in XML format. You also require authorization for the relevant functions and documents. • <i>No Authorization</i> – You cannot export data in XML format.
<i>MS-EXCEL</i>	<ul style="list-style-type: none"> • <i>Full Authorization</i> – You can export data to Microsoft Excel. You also require authorization for the related functions. • <i>No Authorization</i> – The Export to Microsoft Excel icon  is not active for you. <p>i Note</p> <p>If you have no authorizations except for <i>Export to MS-Excel</i>, only the main menu and the <i>MS Excel</i> icon are active when</p>

<i>MS-WORD</i>	<ul style="list-style-type: none"> • <i>Full Authorization</i> – You can export documents, letters, and reports to Microsoft Word. • <i>No Authorization</i> – The <i>Export to Microsoft Word</i> icon  is not active for you.
<i>Period Status: Unlocked except Sales</i>	<ul style="list-style-type: none"> • <i>Full Authorization</i> – You can add documents even when the posting period status is <i>Unlocked Except Sales</i>. You must have authorization to add the relevant document. • <i>No Authorization</i> – You cannot add documents when the posting period status is <i>Unlocked Except Sales</i>.
<i>Period Status: Closing Period</i>	<ul style="list-style-type: none"> • <i>Full Authorization</i> – You can add documents even when the posting period status is <i>Closing Period</i>. You must have authorization to add the relevant document. • <i>No Authorization</i> – You cannot add documents when the posting period status is <i>Closing Period</i>.
<i>Launch Application</i>	<ul style="list-style-type: none"> • <i>Full Authorization</i> – The user can open the <i>Launch Application</i> window and run external applications. • <i>No Authorization</i> – The user cannot open this window.
<i>Drag & Relate</i>	<ul style="list-style-type: none"> • <i>Full Authorization</i> – You can access and use the <i>Drag & Relate</i> tab functions (<i>Main Menu</i> → <i>Drag & Relate</i> tab). You can grant authorizations for specific <i>Drag & Relate</i> categories to different users. For example, a user can be authorized for <i>Sales – A/R</i> but not for <i>Financials</i>. • <i>No Authorization</i> – The <i>Drag & Relate</i> tab is not displayed in the <i>Main Menu</i>, even if you have full authorization for the <i>Drag & Relate</i> subcategories. <p>To provide authorization for <i>Drag & Relate</i> functions for certain modules only, grant full authorization to the <i>Drag & Relate</i> category, and then set <i>No Authorization</i> for those modules from which the user should be excluded.</p>
<i>Sales A/R</i>	<ul style="list-style-type: none"> • <i>Full Authorization</i> – You can access and use the <i>Drag & Relate</i> tab functions for <i>Sales A/R</i>. • <i>No Authorization</i> – You cannot use the <i>Drag & Relate</i> functions for the <i>Sales A/R</i> module. <p>To open documents and the <i>Item Master Data</i> window, you require either <i>Read Only</i> or <i>Full Authorization</i> rights for the business partner master data.</p>
<i>Purchasing – A/P</i>	<ul style="list-style-type: none"> • <i>Full Authorization</i> – You can access and use the <i>Drag & Relate</i> tab functions for the <i>Purchasing A/P</i> module. • <i>No Authorization</i> – You cannot use the <i>Drag & Relate</i> functions for the <i>Purchasing A/P</i> module.

	<p>To open documents and the <i>Item Master Data</i> window, you also require either <i>Read Only</i> or <i>Full Authorization</i> rights for the business partner master data.</p>
<i>Business Partners</i>	<ul style="list-style-type: none"> • <i>Full Authorization</i> – You can access and use the <i>Drag & Relate</i> tab functions for business partner information. • <i>No Authorization</i> – You cannot use the <i>Drag & Relate</i> functions for business partner information. <p>You require authorization for <i>Business Partner Master Data</i> to open activities, and <i>Read Only</i> or <i>Full Authorization</i> is also required to set up and use the payment terms (<i>Administration</i> → <i>Setup Business Partners</i> → <i>Payment Terms</i>).</p>
<i>Inventory</i>	<ul style="list-style-type: none"> • <i>Full Authorization</i> – You can access and use the <i>Drag & Relate</i> tab functions for the <i>Inventory</i> module. • <i>No Authorization</i> – You cannot use the <i>Drag & Relate</i> functions for inventory information. To open the <i>Item Master Data</i> window or the <i>Bill Of Materials</i> window, you require either <i>Read Only</i> or <i>Full Authorization</i> rights for item groups, warehouses, and manufacturers. You also require <i>Read Only</i> or <i>Full Authorization</i> for the setup of the item groups, warehouses, and manufacturers (<i>Administration</i> → <i>Set up</i> → <i>Inventory</i>).
<i>Production</i>	<ul style="list-style-type: none"> • <i>Full Authorization</i> – You can access and use the <i>Drag & Relate</i> tab functions for the <i>Production</i> module. To open the production order from within the <i>Drag & Relate</i> tab, you require <i>Read Only</i> or <i>Full Authorization</i>. • <i>No Authorization</i> – You cannot use the <i>Drag & Relate</i> functions for production information.
<i>Financials</i>	<ul style="list-style-type: none"> • <i>Full Authorization</i> – You can access and use the <i>Drag & Relate</i> tab functions for the <i>Financials</i> module. You also require authorization for the chart of accounts and the journal entry. • <i>No Authorization</i> – You cannot use the <i>Drag & Relate</i> functions for financials information.
<i>Service</i>	<ul style="list-style-type: none"> • <i>Full Authorization</i> – You can access and use the <i>Drag & Relate</i> tab functions for the <i>Service</i> module. You also require <i>Read Only</i> or <i>Full Authorization</i> to open the service contract, service call, and customer equipment card. • <i>No Authorization</i> – You cannot use the <i>Drag & Relate</i> functions for service information.
<i>Renaming Fields</i>	<ul style="list-style-type: none"> • <i>Full Authorization</i> – You can open the <i>Change Description</i> window and change field names (CTRL+ double-click a field name). You also require authorization for the relevant document. • <i>No Authorization</i> – You cannot open this window.

Relationship Map	<ul style="list-style-type: none"> • <i>Full Authorization</i> – You can open the Relationship Map window (Goto → Relationship Map) to see a visual of an object's relations with other objects. • <i>No Authorization</i> - You cannot open this window.
Future Posting Date in Documents	<ul style="list-style-type: none"> • <i>Full Authorization</i> – You can enter a future posting date in sales and purchasing documents if Allow Future Posting Date checkbox is selected (Administration → System Initialization → Document Settings). • <i>No Authorization</i> – You cannot enter future posting dates.
Logger Settings	<ul style="list-style-type: none"> • <i>Full Authorization</i> – You can open the Logger Settings window (Help → Support Desk) to log file parameters. • <i>No Authorization</i> - You cannot open this window.

The following modules and functions define the *Customization Tools* authorizations:

<i>Customization Tools</i>	<ul style="list-style-type: none"> • <i>Full Authorization</i> – You can use all the functions of the <i>Customization Tools</i> and make required changes or define new settings. • <i>Read Only</i> – You can view the data defined in all the <i>Customization Tools</i>. • <i>No Authorization</i> – You cannot access any of the <i>Customization Tools</i>. <p>i Note</p> <p>If you select the <i>Read Only</i> authorization for all the <i>Customization Tools</i>, functions for which this authorization is not available are automatically set to <i>No Authorization</i>.</p>
<i>User-Defined Values - Setup</i>	<p>You require authorization for the relevant windows. To have authorization to queries in the <i>Query Manager</i>, you must have authorization for the "Saved Queries - Group No. X" fields (<i>Reports</i> → <i>Query Generator</i> → <i>Saved Queries - Group No. X</i>).</p> <ul style="list-style-type: none"> • <i>Full Authorization</i> – You can create and search for user-defined values in many fields in SAP Business One (<i>Tools</i> → <i>Customization Tools</i> → <i>User-Defined Values</i>). • <i>Read Only</i> – You can view existing formatted searches but cannot modify them. • <i>No Authorization</i> – You cannot define or view formatted searches.
<i>User-Defined Fields - Management</i>	<ul style="list-style-type: none"> • <i>Full Authorization</i> – You can view, modify and create user-defined fields (<i>Tools</i> → <i>Customization Tools</i> → <i>User-Defined Fields Management</i>). • <i>No Authorization</i> – You cannot open this window.
<i>Execute Commands</i>	<p>Relevant for Israel only.</p> <ul style="list-style-type: none"> • <i>Full Authorization</i> – You can access the <i>Execute Commands</i> window (<i>Administration</i> → <i>Utilities</i> → <i>Execute Commands</i>) and execute commands written as macros.

	<ul style="list-style-type: none"> • <i>Read Only</i> – You can access the <i>Execute Commands</i> window, but you cannot execute commands. • <i>No Authorization</i> – You cannot open this window.
<i>User-Defined Object Registration</i>	<ul style="list-style-type: none"> • <i>Full Authorization</i> – You can access the user-defined objects registration wizard (<i>Tools</i> → <i>Customization Tools</i> → <i>Objects Registration Wizard</i>). You can load DLL files that are created by partners for user-defined objects (that are also created by partners). This means that business logic, which is not part of the core application, can be added and activated throughout the application like any other built-in functions. • <i>No Authorization</i> – You cannot view or open the wizard.


Administration Module Authorizations

The following modules and functions define the *Administration* authorizations:

<p><i>Administration</i></p>	<ul style="list-style-type: none"> • <i>Full Authorization</i> – You can enter all <i>Administration</i> module functions and make required changes or new settings. • <i>Read Only</i> – You can view the data defined in the <i>Administration</i> module. • <i>No Authorization</i> – You cannot access any of the functions in the <i>Administration</i> module. <p>i Note</p> <p>If you select the <i>Read Only</i> authorization for the entire <i>Administration</i> module, functions for which this authorization is not available are automatically set to <i>No Authorization</i>.</p>
<p><i>Exchange Rates and Indexes</i></p>	<ul style="list-style-type: none"> • <i>Full Authorization</i> – You can open the <i>Exchange Rates and Indexes</i> window (<i>Administration</i> → <i>Exchange Rates and Indexes</i>) and enter relevant exchange rates. • <i>Read Only</i> – You can view the data in the <i>Exchange Rates and Indexes</i> window. • <i>No Authorization</i> – You cannot open the <i>Exchange Rates and Indexes</i> window. <p>i Note</p> <p>When no authorization is granted for sales or purchasing documents and payments, or when a foreign or all currency business partner, or an item with a foreign price, is selected, you are not able to enter an exchange rate in the <i>Exchange Rates and Indexes</i> window for that date.</p> <p>If you have already defined an exchange rate for that date, this setting has no effect.</p>
<p><i>System Initialization</i></p>	<p>Controls your access to the functions in the <i>System Initialization</i> menu. The authorizations selected in the <i>System Initialization</i> row apply to all system initialization functions.
